Summary

Monthly subscription fees paid for enrolled youngsters attending meetings remained at £12.50 during the financial year. They increased for the first time in several years to £15 in April 2025. There are still a number of payments being received by Bank transfer at £12.50 so if you have not yet amended your bank transfer could you please do so.

There was an increase in collected payments in part due to the reintroduction of Squirrels, and an increase in the number of members in other sections. to £10,029.34. This is reflected in the amount paid in January to Swanley District for annual membership/capitation of £4,773.50.

Gift aid for the calendar year 2023 was received at £1523.33 and £1690.45 for 2024.
